- 1. Candidates are advised to read all terms and conditions and instructions of the Advertisement carefully in order to submit their online applications complete in all respects.
- 2. Interested applicants are required to apply through prescribed job application form available at university website (<a href="https://uoj.edu.pk">https://uoj.edu.pk</a>) and MUST also submit the application form (hard form) along with required documents.
- 3. Three sets of the application dossier duly bound on the prescribed proforma along with detailed CV and attested documents (Degrees/Certificates/Transcripts, experience certificates, CNIC, Domicile (Punjab), 2-recent photographs etc. should reach the Registrar Office, University of Jhang on or before the closing date.
- 4. Applicants already working in Government / Semi-Government organizations / Autonomous Bodies should apply through proper channel by due date along with No Audit / No Inquiry / No Demand Certificate; otherwise, their applications will not be entertained. However, the University may entertain advance copies (subject to provision of NOC / Certificates within the 15 days after the last date of submission of applications.
- 5. The University reserves the rights to not fill any post, withhold the appointment against any advertised post or accept/reject any application without assigning any reason.
- 6. The responsibility of authenticity/ genuineness of the documents / data provided / given with the application will rest absolutely on the applicant. In case any information provided by the applicant in his / her application form is found incorrect or false at any stage, he / she will be disqualified and action will be taken under the Rules.
- 7. Dismissed / terminated from the service or penalized, by any of the University / Government Department / Autonomous Body / Semi Government / Service Tribunal or any court of Law are not eligible to apply against aforementioned posts.
- 8. Only the post qualification experience of BS-17 and above or equivalent is acceptable for appointments.
- 9. Experience in private entities shall only be accepted if such entity is registered with SECP, Registrar of Firms of any other regulatory authority.
- 10. Experience from Firms/ Companies/ Institutions/ Organizations/ Banks/ NGOs etc., will be accepted if these are well known nationally or internationally, have appropriately been registered/ incorporated with concerned government department/ institution for doing business, maintain office (s) and have proper registration number/ reference number, where applicable.
- 11. The experience gained on Daily Basis, Part time, Visiting, Honorary / self-employed and apprentice/ internee/research scholar/research associate/teaching assistant will not be considered/ counted as experience.
- 12. The applicant(s) having foreign degree must attach HEC/IBCC equivalence certificate (issued & Attested by the HEC/IBCC) with the application form.
